PROPOSED BOUNDARY CHANGES AND SIX NEW SUBURBS IN THE BLACKTOWN CITY COUNCIL AREA

The Geographical Names Board (GNB) is seeking public comment on a proposal from Blacktown City Council to change existing suburbs in its Local Government Area.

The proposal is to amend the suburb boundaries of Marsden Park, Schofields, Riverstone, Rouse Hill, Vineyard, Quakers Hill and Shanes Park. The amendments will result in the creation of six new suburbs named:

Melonba - Darug name for a type of wattle found in the area, commonly known as black wattle or early green wattle.

Angus - After John Angus a successful businessman and Shire President, Blacktown Shire Council 1917 to 1920.

Richards - After Benjamin Richards who is credited with establishing the Riverstone Meatworks in 1878.

Kwigan - Darug name for a type of native cherry found in the area.

Wran - Named after Neville Wran NSW Premier from 1976 to 1986.

Lynch - After former Mayor Jim Lynch. He was first elected to council in 1977, he was part of the team that lead to Blacktown being declared a City in 1979. Lynch was Mayor of Blacktown from 1981-1985.

The proposed new suburbs supports the planned development of the area. This development will need to cater for a population increase that will take place over the next 20 years.

“An important element of determining place names and boundaries is endeavouring to meet the approval of affected residents,” said Mrs Narelle Underwood, Chair of the Geographical Names Board.

“So, it can consider resident feedback the GNB is encouraging community comment before it considers adopting Council’s proposal”.
